# 4. Review and Approve 2023-24 Minutes

# 5. Presentation of the Proposed Budget FY 2024-25

X. Augerot: Will the staff please present the proposed budget?

Marilee Hoppner (M. Hoppner) presented the budget: The South Third Sewer District serves 38 customers. 70% of the operating costs are paid to the City of Corvallis for maintenance of the system. We're expecting city utility rates to increase again, so this budget is assuming a 5% per month increase in rates per customer which would net an additional \$2,280 in revenue. The rate increases will offset operating costs including increases related to the financial system billing software which had a 75% increase in rate from \$1,600/year to \$2,800/year and a 3% increase from the City of Corvallis that went into effect February 1st; we are expecting a 5% increase effective February 1, 2025. The obligation to the general fund has been closed out this year, and so there is no budget for next year. We did have to recognize bad debt of \$3,776 against the 2024 budget. Does anyone have any questions?

#### 6. Committee Questions

S. Signs: If there's no budget, does that mean the end to the maintenance service charges? Or does that change at all?

M. Hoppner: The debt service is done; those were the loans that were created several years ago when the system was set up, and the final payment was made by the final person who was making payments. We had one person that defaulted on the loan and they have both passed, so their loan will be tied to the house, and if the house is sold then we would get a lien against it and be able to get those funds back. We don't have any more payments due to the general fund for that debt service.

# 7. Public Hearing on Proposed 2024-25 Budget
