Budget Discussion

The budget was built with a \$3/mo. (4.5%) increase in rates per homeowner in response to expected increase in operating costs. The last increase was in 2024. 66% of the operating costs of the district are paid to the City of Corvallis. City increases rates each February. City increased rates 5% 2/1/2025 and added estimate of 5% for expected increase 2/1/2026. Maintenance responsibility rests with the City of Corvallis.
